Abu Dhabi Advances \$1bn Hydrogen Project in Kizad

Land has been allocated for the planned green hydrogen and green ammonia project in Khalifa Industrial Zone Abu Dhabi (Kizad). Abu Dhabi announced the AED 3.7bn (\$1bn) facility as well as the formation of Helios Industry, a special project vehicle to implement the scheme, in May. The overall project will include an 800 MW solar photovoltaic (PV) plant to power hydrogen-to-ammonia production. The plant is expected to produce 200,000 tonnes of green ammonia for export annually once completed. The project's initial phase entails a 300 MW solar PV plant and an estimated 35,000 tonne-a-year ammonia production facility.-8th April 2022

Its targeted net production for 2022 is 600 million to 610 million barrels of oil equivalent (BOE), of which, production from China and overseas will account for approximately 69 per cent and 31 per cent, respectively8 th April 2022.

GERMANY	OGE plans pipeline link for Wilhelmshaven LNG terminal Open Grid Europe (OGE) plans to build a 30km LNG link from a planned terminal at the North Sea port of Wilhelmshaven by the end of the year. The link will run from Wilhelmshaven to NETRA, a long-distance pipeline taking gas further south and east, reaching NETRA at a point near the Etzel underground storage facility. The pipeline is expected to have initial capacity of 10 Bm³, potentially increasing to 28 Bm³ with further expansion of the network over the next few years, according to OGE 8 th April 2022

BRAZIL	 Prosafe declared lucky winner of Petrobras tender Offshore accommodation provider Prosafe has been declared the winner of a bidding process for a four-year contract by Petrobras in Brazil. The total value of the contract associated with the bidding process is approximately \$110 million. A contract, if awarded, has a firm period commitment of four years and the start date is in 3Q/4Q 2022 following on from the expiry of its current mutually extended three-year contract that started in Q4 2016. Back in November 2021, Petrobras extended the contract for the unit, taking the firm operational period through to mid-July 20228th April 2022 Brazil auctions 59 oil blocks; Shell, TotalEnergies, 3R win contracts Brazil on Wednesday granted 59 exploratory blocks of oil and natural gas to 13 companies, including Shell (SHEL.L), TotalEnergies (TTEF.PA) and 3R Petroleum (RRRP3.SA). The auction totaled 422.4 million reais (\$90.10 million) in signature bonus, registering a premium of 854.84%, according to data from the country's oil regulator ANP. The areas that were sold are located in six Brazillian states and will result in investments of 406.3 million reais in the exploratory phase of the contract. Shell Brasil was granted six blocks in the Santos Basin in a consortium with the Colombian Ecopetrol, while TotalEnergies won two areas in the same basin. The Brazillian company 3R Petroleum got six areas in the Potiguar Basin. In a statement, Shell said Wednesday's auction represented "another milestone" in its focus on Brazil, a country that accounts for about 13% of its global oil and gas production. With the new acquisitions, the company now holds more than 30 oil and gas contracts in the country14th April 2022
